Women in the Arts Retreat 2021







OCTOBER 21, 2021 MINUTES

Call to Order The October meeting of Gamma Alpha was called to order at 6:44 pm by Amy Wright. She asked for a motion to approve the minutes of the September 13th meeting were approved.

President's Report Amy reported to the group the highlights of The Women in Arts Retreat. Cindy Dietz and Pam Hudson also attended. Amy showed pictures of the leaders who introduced different crafts in which participants could get involved. The crafts that were taught were: How to make beautiful bows, leaf painting, salt watercolor painting, jewelry making, diamond painting, and a book folding project. There were also instructions on how to use a Cricket machine. It was a very enjoyable time for all who attended.

Treasurer's Report Annual Audit - It was reported that Cindy Dietz prepared the annual audit and it was completed by Judi Fisher and Jackie Smart at Cindy's home.

Financial Statement for 2020-2021

Checking Balance: \$1,936.55 Savings Account: \$16,400.69

There are contribution checks totaling 1236.38. Other revenue is expected and the total balance will be posted after the auction in November.

Annual Auction Jackie Smart announced that this auction will be held on November 7, 2021 at Laurel Park Manor. 72people have signed up. A revised list of duties will be posted soon. She said that some members have sent in generous donations: Pam Husson-\$100.00, Barb Anderson-\$85.00, Pam Emerson-items for the auction, and Judy Handley— hand-knitted projects. Jackie also reviewed how to fill out Donation forms for the State of Michigan and the cards for the donations. There will be 3 tables set up for the auction: the yellow cups tables are items valued at \$1-\$25, the blue cups tables are for items valued at \$25-\$50, and Silent Auction tables with items valued at \$50 or more. There will also be 50-25/25 raffles. She asked members to bring lots of items.

RECIPES

JAMIE OLIVER SCONES

During COVID, I started baking (something I am not very good at. I tried lots of scone recipes. This was the one my family loved. They turn out very moist and not dry like most scone recipes I tried.

INGREDIENTS

I cup of Golden Raisins soaked in orange juice Zest of the orange 1 teaspoon of orange flavoring 150 g cold unsalted butter (10.582 TBS) 500 g self-rising flour, plus a little extra for dusting 3 level teaspoons baking powder 1/3 cup sugar 2 large free-range eggs 8 ounces of cream, plus a little extra for brushing



A cup of tea with a warm scone is divine on a chilly day.

METHOD

Put the dried fruit into a bowl. Zest the orange with a rasp grater. Then squeeze the juice into the bowl of raisins. Add the teaspoon of orange flavoring and let sit for ideally a couple of hours.

Preheat the oven to 180 C/400°F

Sift the flour, baking powder, sugar and a good pinch of sea salt into a mixing bowl.

Add the cubed cold butter and use your thumbs and forefingers to break up the butter and rub it into the flour so you get little cornflake-sized pieces.

Beast the eggs and cream.

Make a well in the middle of the dough, add the eggs and cream, and stir it up with a spatula. Do a little at a time.

Add your soaked raisins to the mixture. Add a tiny splash of cream if needed, until you have soft, dry dough. Move it around as little as possible to get it looking like a scruffy mass — at this point, you're done. Sprinkle over some flour, cover the bowl with cling film and pop it into the fridge for 15 minutes. Roll the dough out on a lightly floured surface until it's about 2 to 3 cm thick. With a 6cm round cutter or the rim of a glass, cut out circles from the dough and place them upside down on a baking sheet — they will rise better that way (so they say). Re-roll any offcuts to use up the dough.

Brush the top of each scone with the extra milk or some melted butter and bake in the oven for 12 to 15 minutes, or until risen and golden. At that point, take them out of the oven and leave them to cool down a little.

Tips

If you don't want to bake a whole batch, freeze the scones after you've cut them out. That way, another day you can just pop the little rounds of frozen dough into the oven and cook them at 180° C/350°F/gas 4 for 25 minutes, or until golden and lovely. I used my scale for all measurements (Jackie)

Substitution for heavy cream

1. Milk and Butter

Combining milk and butter is an easy, foolproof way to substitute for heavy cream that'll work for most recipes. The butter adds extra fat to the milk, making its fat percentage similar to that of heavy cream.

Combine 1/4 cup (57 grams) of melted butter with 3/4 cup (178 ml) of milk and mix thoroughly to make 1 cup (237 ml) of heavy cream. You can also add a tablespoon (8 grams) of flour to thicken the liquid, especially if you're using low-fat milk.

Keep in mind that this substitute works well for cooking and baking recipes in which heavy cream is used to add flavor and creaminess. However, it won't whip the same way that heavy cream does.


If the Creek Don't Rise By Leah Weiss

He's gonna be sorry he ever messed with me and Loretta Lynn.

In a North Carolina mountain town filled with moonshine and rotten husbands, Sadie Blue is only the latest girl to face a dead-end future at the mercy of a dangerous drunk. She's been married to Roy for fifteen days, and even with a baby due, she knows now that she should have listened to the folks who said he was trouble.

Sadie is desperate to make her own mark on the world, but in remote Appalachia, a ticket out of town is hard to come by and hope often gets stomped out. But when a stranger sweeps in and knocks the world off-kilter for everyone in town, Sadie finds herself with an unexpected lifeline...if she can just figure out how to use it. Sadie begins to think there might be more to life than being Roy's wife and punching bag.

As stark and magnificent as Appalachia itself, *If the Creek Don't Rise* is a bold and beautifully layered debut about a dusty, desperate town finding the inner strength it needs to outrun its demons. The characters of Baines Creek will take you deep into the mountains bursting heart, honesty, and homegrown grit. With a flair for the Southern Gothic, *If the Creek Don't Rise* is a debut novel from Lean Weiss.

DKG International News

Austin, Texas: Society Headquarters Building Update

As you probably know, DKG International has been involved in the process of selling our headquarters building in Austin for the past two years. That process has been completed and the sale was final on September 1, 2021. Because the building is considered a permanent asset, the proceeds from the sale of it were appropriately deposited into the Permanent Fund of the Society.

The Constitution defines in Article IV how the monies in the Permanent Fund may be used and will be the guide for any future use of the sale proceeds. The Board's primary concern leading to the sale was a consideration of the continued and potential cost to members regarding maintenance costs, taxes, structural constraints, and a variety of increasing expenses relating to the building. As the managing authority of both the building and its contents, the Board also authorized the consideration of appraisal firms to value and possibly sell redundant items in the building. A previously appointed ad hoc committee, consisting of board members, members, and staff, is working on a recommendation regarding archiving, preserving and keeping, moving, selling and/or disposing of the furnishings and other items in the building. The recommendation from that committee will be considered by the Board during its next meeting.

The conversations surrounding next steps will now transition into action as the plans to move to a new site are being finalized. Under a lease agreement, the building will be occupied by DKG for six (6) months after the sale.

At the meeting of the International Administrative Board in August, it was determined that it would be in the Society's best interests to lease office space for the immediate future. If future ownership is considered, a constitutional amendment would be required in order to purchase an existing building in lieu of land development or construction.
